

# CLUNES PUBLIC OPEN SPACE MASTER PLANS PROJECT

## PROJECT BULLETIN #1

### Project Background

**Hepburn Shire Council is developing Masterplans for the Bull Milgate Reserve (Clunes Recreation Reserve), Queens Park and Pioneers Park in Clunes.**

The masterplanning seeks to address any current gaps in infrastructure requirements; improve accessibility and safety environments; and increase participation, visitation and reserve connection opportunities for the local community.

The project will identify and assess both formal and informal sport and recreation opportunities to ensure a collaborative approach to planning, design and management of the local facilities.

The final Masterplans will inform Council's future planning, provision and enhancement of the three Reserves over the next 10 years and will be key planning and implementation documents for both government and community stakeholders.

### Project Consultants

Council has engaged leading sport and recreation consultants, *insideEDGE* Sport and Leisure Planning to facilitate the Clunes Public Open Space Masterplans Project.

*insideEDGE* will be working with experienced landscape architects, ACLA Consultants and Millar Architects.

The consultancy team has significant experience within their specialist fields and have completed a range of similar projects for councils throughout metropolitan Melbourne, regional Victoria and South Australia.
